

OUR GRANTMAKING



FROM 2020 TO 2024, BLACK FREEDOM FUND GRANTED \$40 MILLION TO BLACK-SERVING ORGANIZATIONS, RESULTING IN THE LARGEST POOLED TRANSFER OF WEALTH TOWARD BLACK ORGANIZING IN HISTORY.

We believe those closest to the issues impacting our communities know best how to solve them. That's why we invest in visionary leaders and grassroots organizations, advancing community-led and centered agendas to secure a future where all Black people thrive.

From 2020 to 2024, Black Freedom Fund granted \$40 million to Black-serving organizations, resulting in the largest pooled transfer of wealth toward Black organizing in history. Our investments prioritize courageous and visionary grassroots organizations, funding power-builders who often do not have access to traditional philanthropy.

Black Freedom Fund focuses on multi-year, unrestricted funding, capacity building assistance, and movement infrastructure, so grassroots leaders and communities have the sustained support they need to transform systems and write a new legacy of racial justice. We are proud to support leaders and organizations throughout the state that are catalyzing change across 17 issue areas.





INITIATIVES ADVANCING EQUITY AND JUSTICE

OKOBI SABBATICAL PROGRAM

The Chinedu Valentine Okobi Sabbatical Program was created in 2024 to honor the life and legacy of Chinedu Valentine Okobi, a devoted father, poet, brother, son, and Morehouse graduate, who was tased and beaten to death by San Mateo sheriffs in October of 2018. In his memory, Chinedu's family invested funds they received from their lawsuit against San Mateo County to create a sabbatical program for leaders of Black power-building and racial justice organizations.

Black Freedom Fund administers the sabbatical program in partnership with G4GC. Through the sabbatical program, each participant's organization is resourced to allow the leader to take a six-week sabbatical, for restoration and wellness amidst the ongoing challenges of being on the frontlines of racial justice organizing and advocacy.

LEAD™ FOR RACIAL JUSTICE

With heightened attacks on racial justice programs across the country, Black Freedom Fund saw an urgent need to provide grassroots organizations and funders with accurate and timely information to be better equipped to continue their work and protect their communities.

Black Freedom Fund's Legal Education, Advocacy and Defense for Racial Justice™ (LEAD) Initiative was launched in May 2024 to strengthen our collective resolve to advance racial justice by offering community and philanthropic partners:

- clear legal analysis
- virtual & in-person trainings
- organizational assessment tools
- technical assistance



In partnership with legal experts, advocates and funders, LEAD has provided pro-bono assistance and tools to help organizations navigate the changing legal landscape and conduct risk assessments, and strategic

communications counsel to continue their vital work. LEAD is gaining momentum beyond California as BFF is supporting the deployment of LEAD in Minnesota, Washington, and Oregon.

STATE OF BLACK CALIFORNIA:

CENTERING BLACK COMMUNITIES IN POLICY CONVERSATIONS

From June through December 2024, the Black Freedom Fund partnered with the California Legislative Black Caucus to launch the State of Black California—a powerful, statewide event series to create space for Black Californians to engage policymakers on the issues that impact the Black community.

In six cities—San Diego, Santa Barbara, Fresno, Sacramento, Moreno Valley, and Oakland—hundreds of community members gathered with local leaders and legislators for urgent conversations on housing, education, economic opportunity, public safety, and reparative justice. The series offered a critical platform for grassroots organizations and Black Californians to engage

directly with lawmakers and shape solutions grounded in lived experience and share their opinions on the movement for reparations.

The cities were chosen as part of an overarching strategy to reach and hear from as many Black Californians as possible, especially those in geographic areas often overlooked and underrepresented.



CITIES REACHED

650 IN-PERSON ATTENDEES 1000 ONLINE VIEWS

Each event amplified key policy priorities, including the California Legislative Black Caucus's 2024 Reparations Priority Bill Package, and affirmed the collective vision for a California where Black communities can thrive.

While Black communities throughout the state have made progress over the last 30 years, they continue to face higher rent burdens, lower homeownership rates, and greater unemployment numbers than other groups.

At 13%, Solano County in the Bay Area has the highest percentage of Black people in the state. Over 90% of respondents at each of the six locations reported having a better understanding of the movement for reparations in California after attending the State of Black California.

The immigrant share of Black Californians continues to steadily increase, from just 3.4% in 1990 to 7.8% in 2021.

Black communities are ready to be moved from passive supporters to engaged reparations advocates, but want resources — conversation guides, reading materials and handouts, and trainings.

We are proud to support Black power-building and movement based organizations across California—visionary leaders and grassroots changemakers who are driving bold solutions in their communities. From arts and education to housing, health, and economic justice, these organizations reflect the power, resilience, and innovation of the Black freedom movement.

THE VILLAGE METHOD, SOUTHERN ALAMEDA COUNTY

The Village Method (TVM) is a grassroots organization dedicated to empowering Black youth and families in Southern Alameda County. They provide culturally affirming youth development, family engagement, and community outreach to ensure academic success and community involvement.

In 2024, TVM expanded its reach to support over 125 families and five schools, including a new school district. They strengthened their team and were recruited into the Bay Area Coalition for Educational Justice, thanks in part to BFF's support.

It also supports our ability to train parent leaders, local educators and community partners through a workshop series that shares our culturally affirming, family-led model rooted in African American heritage and tailored to the realities of Black families navigating today's education systems."

INLAND EMPIRE BLACK WORKER CENTER, RIVERSIDE AND SAN BERNARDINO COUNTIES

The Inland Empire Black Worker Center (IEBWC) is dedicated to building power with Black workers in Riverside and San Bernardino counties by advancing economic justice, workplace rights, and equitable employment opportunities. Through organizing, leadership development, and policy advocacy, IEBWC strengthens the voice and visibility of Black workers across the region.

In 2024, IEBWC expanded its outreach and education efforts, reaching more than 2,800 workers in person and

27,000 community members through digital campaigns and publications. Over 50 Black workers graduated from IEBWC's leadership development programs focused on workplace rights, organizing, and advocacy. These leaders mobilized more than 700 residents, hosting Know Your Rights trainings, leading campaigns against wage theft and unsafe working conditions, and testifying at public hearings. Their collective efforts contributed to three major policy wins that expanded protections and fair hiring practices for Black workers.

TRANSGENDER DISTRICT, SAN FRANCISCO

Founded in 2017 by three Black trans women, The Transgender District is the world's first legally recognized transgender cultural district. Located in San Francisco's southeastern Tenderloin neighborhood, the district aims to honor the rich history, culture, and legacy of transgender people, particularly Black trans women. Its mission is to stabilize and economically empower the transgender community through ownership of homes, businesses, historic and cultural sites, and safe community spaces.

In 2024, The Transgender District expanded its Rent Stabilization Program to support transgender and gender nonconforming (TGNC) residents, hosted its largest-ever Health and Wellness Fair in San Francisco's Tenderloin, and launched Empowerment Month to celebrate TGNC resilience through workshops, arts, and community events. Additionally, 14 TGNC entrepreneurs graduated from their Entrepreneurship Accelerator Program, furthering economic empowerment within the community.

UNCOMMON LAW, STATEWIDE CALIFORNIA


UnCommon Law is dedicated to transforming California's parole system by providing trauma-informed legal representation, mental health counseling, and legislative advocacy. They focus on supporting individuals navigating the discretionary parole process, particularly those serving life sentences for serious or violent crimes.

In 2024, UnCommon Law made significant strides in parole justice. They co-sponsored AB 2310, a bill signed

into law in September 2024, which enhances language access for parole candidates with limited English proficiency by requiring the translation of key documents into the top five non-English languages. Additionally, the organization trained 180 incarcerated individuals through mentorship and fellowship programs, empowering them to become leaders and advocates for policy change.

COMMUNITY INTERVENTIONS & CENTER FOR THIRD WORLD ORGANIZING (CTWO), CENTRAL VALLEY

In 2024, Community Interventions strengthened its grassroots organizing in the Central Valley by hosting two fellows from the Movement Activist Apprenticeship Program (MAAP), through a partnership with the Center for Third World Organizing (CTWO) and BFF.

MAAP is a paid summer intensive training program led by BFF grantee CTWO that provides young, emerging leaders the opportunity to develop skills and experience in grassroots organizing. For over 30 years, MAAP has been a flagship organizer training program for people of color, bringing motivated young activists together from all over the country to teach them the science and art of organizing communities around their most salient issues.

Together, the MAAP fellows hosted at Community Interventions gained hands-on experience while bringing added capacity to the team, developing and leading an outreach plan that combined in-person and digital strategies to grow the organization's reach.

Hosting MAAP fellows helped Community Interventions grow its campaigns while supporting the development of new Black organizers and strengthening the advocacy ecosystem in California.

STATEWIDE NETWORKS

The Black Freedom Fund's three anchor networks, Black Equity Collective, LIVEFREE CA, and California Black Power Network, are focused on developing the sustainability of Black-serving organizations, strengthening democracy, and building Black futures.

CALIFORNIA BLACK POWER NETWORK

With BFF funding, the California Black
Power Network (CBPN) conducted its
largest civic engagement program to date,
training over 200 grassroots leaders and
490 volunteers who contacted more than
64,000 voters through phone banking and
door knocking ahead of the November 2024
General Election. These efforts resulted in
a 9 percentage point increase in turnout

among Black voters contacted compared to the statewide average. In partnership with its members, CBPN's efforts also led to the registration of over 400 new voters.

Beyond voter outreach, CBPN hosted 34 Black Men's Listening Sessions with over 400 participants and surveyed 537 Black men to uplift their priorities and experiences. The network also conducted California's largest reparations survey, engaging over 1,200 Black Californians to inform ongoing advocacy. Through coanchoring the Alliance for Reparations, Reconciliation, and Truth (ARRT), CBPN advanced 8 reparations bills.



BLACK EQUITY COLLECTIVE

In 2024, the Black Equity Collective (BEC) deepened its power-building work across California, participating in civic engagement and policy advocacy alongside its members. With BFF support, BEC launched the "Equity Can't Be Erased" campaign, uniting over 150 organizations serving the Black community in a collective call for sustained investment in racial equity. The Collective also co-hosted the "Power of the Black Vote" event, a statewide virtual call-to-action convening Black power-building organizations to align resources, share strategies, and mobilize Black voters across California ahead of the 2024 election cycle.

Through leadership cohorts, technical assistance, and facilitating peer learning and funder partnerships, BEC supported member organizations in developing multi-year



resiliency plans, securing \$3.2 million in new grant funding, and strengthening their long-term capacity to build durable Black power.

LIVEFREE CA

In 2024, through BFF funding, LIVEFREE CA strategically invested over \$500,000 directly into the hands of Black-serving organizations and frontline Black organizers through regranting, stipends, and wellness support.

These funds provided stability in the organizing field and ensured that the momentum for racial justice continued through pivotal election years.

BFF's support enabled LIVEFREE CA to continue bridging 20 organizations serving the Black community — from abolitionist and advocacy organizations to faith-rooted congregations and service providers—into one statewide power-building ecosystem.

In 2024, LIVEFREE CA participated in the African American Reparations Taskforce (AART) efforts. With BFF's backing, LIVEFREE CA helped build Black organizing capacity in support of the statewide reparations campaign, mobilizing communities and educating stakeholders on the significance of historical redress and future policy remedies.



PARTNERSHIP IN ACTION

POWER OF THE BLACK VOTE: MOBILIZING BLACK VOTERS

On October 10, 2024, BFF, along with the Black Equity Collective, Black Equity Initiative-Inland Empire, LIVEFREE CA, and the California Black Power Network, co-hosted the Power of the Black Vote: CA Black Voter Rally. This virtual event aimed to ensure that Black communities across California had the tools and information needed to fully participate in the democratic process ahead of the 2024 general election.

The event brought together community members to share critical, nonpartisan information about statewide ballot propositions, voting deadlines, and the issues most impacting Black Californians—from housing and healthcare to public safety and climate justice. The message was clear: Black voters are essential to shaping the policies and

outcomes that affect our everyday lives.

In addition to the rally, BFF provided nonpartisan voter education resources to our network of grantees and philanthropic partners. These tools helped community-based organizations engage their members, host conversations, and encourage informed participation at the polls.

Expand our capacity to provide culturally competent legal and advocacy services to Black immigrants across California, strengthen our campaigns for language justice and abolition, and mobilize community power through coalitions like Dignity Not Detention and Check the Sheriff—ultimately deepening our impact on immigrant justice and racial equity statewide.

- BLACK ALLIANCE FOR JUST IMMIGRATION

Provide critical leadership development services to girls and nonbinary youth of color so that they can hold the powerful accountable and implement self care modalities to sustain their commitment to justice and joy.

- RADICAL MONARCHS

Keep our doors open. As the only Black organization in our County with facilities, the funding from BFF has literally helped us pay our rent and staffing.

- GATEWAY EDUCATIONAL SERVICES

Launch the High Desert Black Worker Center (HDBWC), which is set to fully open in 2025. The HDBWC is part of Millionaire Mind Kid's Reimagine Our Communities (ROC) program and aims to address the employment challenges faced by Black workers in the High Desert area of San Bernardino County.

LABWC has continued to amplify Black worker voices and advance systemic change through strategic engagement with key stakeholders and innovative member-led initiatives with our "Let's Stand on Business" 2024 Black Worker Symposium. The success of initiatives such as the 1000 Strong Campaign and the passage of SB 1340 are direct results of LABWC's leadership approach. Our model prepares Black workers for leadership roles and dismantles hierarchical structures, replacing them with a collective vision of action and accountability that reflects the values of Blackled organizing.



Develop and recruit Black CSA (child sexual abuse) survivors into our cohort Black F.L.I.G.H.T. Our 9-month healing and political education cohort is more than a program; it is an act of liberation. Thanks to BFF, we are able to address an urgent, long-overdue need for transformative healing among Black queer and trans survivors of childhood sexual abuse.

- MIRROR MEMOIRS

Increase our capacity to build power amongst our staff, members, and volunteers to engage Black Women and Girls more intentionally in order to uplift their ideas and voices that lead efforts to advocate for and create systems change at the institutional, city, county and state levels.

- BLACK WOMEN FOR WELLNESS

Expand our Healing Justice programming, held throughout the community and at *The People's House* (our community hub) in Oakland. - ANTI POLICE-TERROR PROJECT (APTP)

Take on legal battle to preserve property, 825 Drake, for community use, bring together leaders in our community to strategize community-wide threats; build a broader coalition, *Save Our City*, to address gentrification and other housing and climate change related issues; and advocate for change of curriculum for *Reading By Third Grade Campaign*.

- THE HANNAH PROJECT PARTNERSHIP

Significantly deepen our collaboration with schools, community organizations, and stakeholders. This enhanced partnership has enabled us to effectively implement restorative justice practices, positive discipline approaches, and impactful educational programs designed to cultivate a supportive and inclusive learning environment for Black students. By actively promoting alternatives to harsh disciplinary measures, we aim to disrupt the cycle of criminalization and foster pathways to success for Black youth.


